Broderick stated she could make calls to the employees from last year if no one had a problem with it. Burton stated calls were made some were not interested, some have not returned his call and one person did apply from last year.

Broderick stated Mayor Fryman stated she would reach out to the manager from a couple of years ago to see if she had any interest.

Broderick would like to have a pool work day, after the features are set up so the building can be cleaned up that day as well.

Burton stated on Friday April 19<sup>th</sup> students from Pioneer would be here to help clean up the park and cemetery. Gretchen will be working at the park with the students.

Broderick stated the goal is to open the pool Memorial Day weekend. She asked Burton to paint the bike rack.

Mr. Cassidy stated we need employees to open.

Burton was also asked to call the Health Department to see how many days we have to stay open for the season in order to operate under the prior regulations.

Broderick would like to see the Pool sign put up at the Park entrance.

### Veterans Park

Broderick asked that the two flags at the Veterans park be replaced. The mound in the back of the park needs to be weeded, sprayed, and re-mulched.

### Basketball court

Broderick stated we need to get the court done. She reiterated on the prior committee and how they were going to renovate the scout hut and had intended to use some of the funds for the basketball backboards. The Fiscal Officer stated the funds were set aside in the ARPA fund for the scout hut, and believed the thought to use the ARPA funds for the backboards was when the renovations were going to be done by members of the committee. It was not done and the Administrator had discussed with the Mayor and Carter about getting the renovations done.

Burton asked if we could use the old backboards.

Broderick stated she did not believe they could, since this was a state grant for a new project.

Broderick stated last year she got a quote on the backboards and frames. They were approximately \$2,800.00 each. Discussion on the backboards and frames. They discussed steel vs. aluminum and other types. Getting a new quote from Thompson and an additional one.

Burton stated he does not have time and man power to prep the site as was quoted in the original estimate from Thompson.

Broderick stated the project needed to be completed by June 24<sup>th</sup>, but she could apply for an extension.

Broderick stated any of the other members are welcome to take over the project.

Cassidy stated he would work with her in the next steps, but he did not want to take it over.
