AN ORDINANCE TO PROVIDE PAY RANGES FOR VILLAGE
EMPLOYEE POSITIONS COMMENCING IN 2022 TO REPEAL
ORDINANCE 19-2021, AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Village of Plymouth, County of Richland, State of Ohio:

SECTION 1. THAT commencing December 26, 2021 the following pay ranges
for the below designated Village employee positions are adopted:


SECTION 3. THAT Council shall by motion establish the regular compensation of each Village employee in accordance with the pay range of this Ordinance.

SECTION 4. THAT Ordinance 19-2021 and any other ordinances contrary hereto are repealed.

SECTION 5. THAT it is hereby determined that this Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of this Village and for the further reason that there is an immediate need to set new wages for Village employees commencing with 2022, and shall otherwise take effect at the earliest time allowed by law., and this Ordinance shall therefore go into immediate effect provided it receives a two-thirds (2/3) vote of all members elected to this Council, otherwise it shall go into effect in thirty (30) days if passed by a majority vote of Council.


