
A RESOLUTION TO APPROVE AND AUTHORIZE THE PURCHASE OF FIFTY TONS OF ROAD SALT BY THE RICHLAND COUNTY, OHIO ENGINEER, AND DECLARING AN EMERGENCY.


WHEREAS, the Richland County, Ohio Engineer makes bulk purchases of road salt on behalf of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PLYMOUTH, COUNTY OF RICHLAND/HURON, STATE OF OHIO:

1. That the Mayor and Village Administrator's contract with the Richland County, Ohio Engineer for the bulk purchase of road salt once the County awards the contract for fifty (50) tons is approved and authorized.
2. That it is hereby determined that this Resolution is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of this Village and for the further reason that there is an immediate need to maintain adequate road salt supplies for road safety, and this Resolution shall therefore go into immediate effect provided it receives a two-thirds (2/3) vote of all members elected to this Council, otherwise it shall go into effect in thirty (30) days if passed by a majority vote of Council.


