

RESOLUTION NO. 9 -2020

Passed June 9, 2020

A RESOLUTION DECLARING THE NECESSITY TO LEVY A RENEWAL OF A 6.0 MILL TAX FOR THE PURPOSE OF THE VILLAGE'S CURRENT EXPENSES IN EXCESS OF THE TEN-MILL LIMITATION, AND DECLARING AN EMERGENCY.

WHEREAS, on the 28th day of April, 2020, this Council adopted a Resolution determining to submit to the electors of the Village of Plymouth, Ohio, described below, a copy of which Resolution was certified to the County Auditor of Richland County, and

WHEREAS, the County Auditor has certified to this Council that the total current tax valuation of the Village of Plymouth, Ohio, is \$18,232,300.00, and the dollar amount of revenue that will be produced annually by the millage stated below would be \$76,500.00.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PLYMOUTH, STATE OF OHIO:


SECTION 1. THAT this Council desires and determines to proceed with the submission to the electors of the question of levying a tax in excess of the ten-mill limitation for the benefit of the Village of Plymouth, Huron/Richland County, Ohio, for the purpose of the Village's Current Expenses per R.C. 5705.19(A), at a rate not exceeding six (6) mills for each one dollar of valuation, which amounts to Sixty Cents (\$0.60) for each one hundred dollars of valuation for five (5) years, and which levy is a renewal of an existing levy of six (6) mills.


SECTION 2. THAT the question of approving the levy shall be submitted to the electors of the Village of Plymouth, Ohio, at the election to be held on the 3rd day of November, 2020, and that said levy be placed on the tax lists of the tax year commencing in 2021, first due in the calendar year 2022, in compliance with the provisions of R.C. 5705.34, if a majority of the electors voting therein vote in favor thereof.

SECTION 3. THAT the Fiscal Officer of this Council is directed to certify a copy of this Resolution to the Board of Elections of Richland County, Ohio, not less than ninety (90) days before the election, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

SECTION 4. THAT it is hereby determined that this Resolution is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of this Village and for the further reason that there is an immediate need to timely file the Resolution with the Richland County Board of Elections to place the levy on the November General Election Ballot, and shall therefore go into immediate effect provided it receives a two-thirds (2/3) vote of all members elected to this Council, otherwise it shall go into effect in thirty (30) days if passed by a majority vote of Council.




